**JUDGMENT/ORDER**

Brief fact of the case is that the above named appellants on 17.10.2019 filed an RTI application under Form-A before the PIO-cum-Addl. Deputy Commissioner, Upper Subansiri, Dimpurijo, whereby, seeking various information regarding the List of Works implemented under Non-BADP during the financial year, 2018-19. The Addl. Deputy Commissioner receiving the said RTI application of the appellant on 22.10.2019 forwarded the same to the District Planning Officer, Daporijo, vide his letter No.DMJ/RTI-01/2019 dated-30.10.2019 for further necessary action. The appellant, having not received the information so sought from the District Planning Officer, Daporijo, being the present PIO, filed the First Appeal before the FAA-cum-Deputy Commissioner, Upper Subansiri District, Daporijo, on 06.12.2019. The appellant, being felt aggrieved of having not been furnished the information so sought within the stipulated time under the RTI Act, filed the Second Appeal before the Arunachal Pradesh Information Commission on 23.01.2020 and the Registry of the Commission on receipt of the same registered it as APIC-30/2020 and processed the same before the Commission for hearing and disposal.

Accordingly, the appeal came up for hearing before the Commission on 2(two) consecutive dates on 03.09.2020 and 01.10.2020. During the first hearing of the appeal on 03.09.2020 the appellant was present and the PIO, Shri Millo Pushang, was though not present, represented by another Shri Tapak Rakmi (SRA) through Audio Conferencing. During the hearing the representative of the PIO informed the Commission that the information so sought were ready for furnishing to the appellant and accordingly, the Commission directed the appellant to collect the information within a week time from the representative of the PIO and to inform to the Commission within a week time from the date of such receipt of the information about his satisfaction or dissatisfaction of the information received. Today, i.e, this 1<sup>st</sup>

day of October, 2020 is the 2<sup>nd</sup> consecutive day fixed for hearing of this appeal. Appellant Talin Dignium and the respondent Shri Millo Pushang, being the concerned PIO-cum-DPO, Daporijo, are both present and being heard through Audio Conferencing. During the course of hearing the appellant expressed his satisfaction as to receipt of the information so sought by him from the PIO and requested the Commission for disposing off and for closure of the appeal.

In view of above I am inclined to dispose off and close the appeal at this stage. And, accordingly, appeal is disposed off and closed.
