**JUDGMENT/ORDER**

Appellant Shri Libi Marde is present in person along with his learned counsel Mr. Domo Boje (Advocate) assisted by Shri K.L Nayam (dvocate). PIO-cum-SE, Er. T. Ligu is also present in person being assisted/ accompanied by Er. Enya Riba, Assistant Engineer, CE's Office Western Zone, Shri D. Chetry (UDC) and Shri S. Lama (LDC) CE's Office Western Zone.

Both appeals, vide APIC-43/2020 relating the CE's Office, WRD, Western Zone and vide APIC-44/2020 relating the CE's Office, WRD, Eastern Zone, are two analogous appeals filed the same appellant against the same PIO and, for the reason why, the both appeals aforesaid are taken together under the common hearing.

Brief fact of the case is that appellant on 05.12.2019 filed two applications under Form-A before the PIO and one of which is seeking information regarding NDRF in respect of the office of the Chief Engineer, WRD, Western Zone and the another is seeking information regarding NDRF and SDRF in respect of the office of the Chief Engineer, WRD, Eastern Zone, for year 2018-19 and 2019-20. The PIO vide his letters, bearing same number and date as I.D.No.89/WRD/RTI/4984 dated-11.12.2019, duly acknowledged receipts of the both applications aforesaid. The appellant, having not received any response from the PIO either in respect of CE's Office, WRD (WZ) or of CE's Office, WRD (EZ), filed the Second Appeals before the FAA-cum-CE, WRD (WZ) and before the FAA-cum-CE, WRD (EZ), on the same date on 24.01.2020. Thereafter, the PIO by his letters, bearing the same number and date vide No.WRD/RTI/05/2010-11(Pt-X/5681 dated-29.01.2020, furnished the
