JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Birendra Tallong on 07.11.2019 filed an RTI application under Form-A before the PIO-cum-EE, RWD Seppa Division, East Kameng District, Arunachal Pradesh, whereby, seeking various information, regarding C/o Construction of Road from Dibru Bridge point to CRC Church, in the year 2015-16, C/o Construction of Road from Agri-Horti office to Govt. Primary School, Police/RWD Colony, in the year 2015-16 and C/o Rostrum at Seijosa, 2019-20. Having receipt of the application of the appellant, PIO furnished those all information so sought to the appellant. Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 23.12.2019. Appellant, having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.02.2020 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 49-2020 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for six consecutive hearings on 03.12.2020, 21.01.2021, 25.02.2021, 22.04.2021, 01.07.2021 and 12.08.2021. Today on 12th August' 2021 is the sixth and final hearing of the appeal. Both PIO and Appellant are present before the Commission through Video Conferencing. PIO has submitted his defense statement in affidavit form and the copy of the same has also been admitted to have received by the appellant. Appellant expressed his satisfaction about the receipt of all information sought from the PIO. Both the appellant and the PIO agreed for disposal of this appeal. Accordingly I find this appeal fit to be disposed off and closed.

In the result this appeal stands disposed off. Judgment/Order pronounced in the open Court of this Commission today on this 12th day of August' 2021. Each copy of Judgment/Order be furnished to the parties.
