ORDER

This is in relation to the judgment/order passed by the Commission on 15th day of October, 2020 in APIC-65/2020, wherein, imposing a penalty of Rs.25000/- (rupees twenty five thousand) only along with a compensation of Rs.5000/- (rupees five thousand) only with a further direction to the PIO to furnish all information so sought to the appellant on or before the 5th day of November, 2020.

Accordingly, the appellant Shri Lishi Tajam and the respondent (PIO) Er. Kago Habung are both present through audio/video conferencing and being heard. During the hearing PIO informed the Commission that he has duly complied with the judgment/order passed by the Commission in this appeal vide APIC-65/2020 on 15.10.2020 in making payments of fines and compensation, including – in furnishing all information so sought in the RTI application of the appellant. All related records of payments of fine and compensation and of furnishing information placed on record before the Commission have carefully been perused. The appellant, on his part, acknowledged the receipt of the compensation paid to him by the PIO and also expressed his satisfaction as to receipt of the information so sought from the PIO.

In view of above I find this appeal fit to be disposed off and closed. And, accordingly, the appeal is disposed off and closed. Each copy of this order be furnished to the parties.


