ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Takheng Lamnio, Gohpur Near KV 2 School, Chimpu P.O.R.K. Mission, Itanagar for non-furnishing of information, by Shri Tungge Loya (APC) , ADC-cum-ERO (PR)-02 Bameng East Zilla Parishad Constituency , Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 23/01/2020.

Whereas, the 1st hearing was held online through Video / Audio conferencing on 9th June' 2020. Shri Tungge Loya (APC) , PIO-cum-ADC, Bameng East Zilla Parishad constituency , Arunachal Pradesh, and the Appellant attended the hearing through audio conferencing. The PIO informed the Commission that the information could not be furnished to the Appellant within prescribed time as the application was not addressed and submitted to him directly. The PIO received the application on 17th February'2020 and information was furnished to the Appellant on 3rd March'2020. Further, additional information were furnished on 18th May'2020.
