ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Shoney Pertin, President Siang Rights Forum(SRF), Airfield Pasighat, Ward No-4, Po/Ps-Pasighat, East Siang District, for non-furnishing of information, by Shri Reri Kato, PIO-cum-EE(RWD), Division Kaying, Siang District, Arunachal Pradesh, as sought, by the Appellants under section 6(1) of RTI Act, 2005 on 03/02/2020.

Whereas, the 1st hearing was held through online Video / Audio conference on 16th June'2020. Shri Reri Kato, PIO-cum-EE(RWD), Division Kaying, Siang District, Arunachal Pradesh, and the Appellant, Shri Shoney Pertin appear in the hearing through Video conferencing. The PIO informed the Commission that he has received the Form-A application on 13th May 2020 by post and have acted upon. The PIO also informed that the Kaying Division was functional w.e.f. 25th July'2017. So, the information, w.e.f. 25th July'2017-2018, 2018-2019 and 2019-2010 have been furnished to the Appellant, in soft and hard copy, i.e. by email and by post. The PIO, asked the Appellant to collect information for the year 2014 to 24th July'2015 from the Division of Aalo and Pasighat. The Appellant informed the Commission that he has received the information as stated by the PIO.

Whereas, the Commission observed that the PIO has not acted upon as per the Section 6(3) of the RTI Act 2005, so the responsibility lies on the PIO to initiate process to procure information as stated above from the Aalo and Pasighat division and furnish the information to the Appellant within 30 days from issue of this order. The Commission asked the Appellant to receive the information and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the rescheduled 2nd hearing was held through online Video / Audio conference on 25th August'2020. Shri Reri Kato, PIO-cum-EE(RWD), Division Kaying, Siang District, Arunachal Pradesh, and the Appellant, Shri Shoney Pertin appeared in the hearing through Video conferencing. The Appellant informed the Commission that he has not got the information for the SL.No. 1 of Form-A, i.e. the **work wise list of LOC** from Pangen Sub-Division from 2014 to 25th July, 2017 which was under WRD Division Pasighat. The PIO informed the Commission that the Appellant did not inform him in this regard. However, the PIO pleaded the Commission and requested to the Appellant to dispose of the case. The PIO assured that he will contact Shri Kipa Rinea, the PIO-cum-Executive Engineer (RWD) Pasighat division and furnish the information to the Appellant within five days. The Appellant agreed to the request of the PIO and appeal the Commission to dispose of the case.

Whereas, the Commission directed the PIO to furnish the remaining left out information to the Appellant within ten days from the issue of this order. The Commission, considering the plead made by the PIO & the Appellant and also taking note of assurance given by the PIO decided to dispose of the case. However, liberty is given to the Appellant to appeal afresh to the Commission if he is not satisfied with the information furnished by the PIO.

Therefore, the case is disposed of.
