ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Shoney Pertin, President Siang Rights Forum(SRF), Airfield Pasighat, Ward No-4, Po/Ps-Pasighat, East Siang District, for non-furnishing of information, by Shri Limi Niri, PIO-cum-EE(PWD), Boleng Division, Siang District , Arunachal Pradesh, as sought, by the Appellants under section 6(1) of RTI Act, 2005 on 03/02/2020.

Whereas, the 1st hearing was held through online video / audio conference on 16th June'2020. Shri Limi Niri, PIO-cum-EE(PWD), Boleng Division, Siang District and the Appellant Shri Shoney Pertin appear in the hearing through online video conferencing. The PIO informed the Commission that all the information sought by the Appellant has been furnished to the Appellant. The Appellant informed the Commission that the information furnished for the Sl.no. 3 is satisfactory but the information furnished for the Sl.no. 1 & 2 are not satisfactory. The PIO instead of furnishing information as sought at Form A, he has replied that the information sought under Sl.no. 1 & 2 are of fiduciary relation. Hence, these information sought cannot be furnished.

Whereas, the Commission found that the information sought in Form A, under Sl.no. 1 & 2 are liable to be furnished to the information seeker. The Commission directed the PIO to furnish the information to the Appellant before 30th June'2020, failing which U/s 20(1) of the RTI Act 2005 shall be imposed on the PIO in the next date of hearing for giving misleading information and denying the information to the Appellant.

Whereas, the rescheduled 2nd hearing was held through online video / audio conference on 18th August'2020. Shri Limi Niri, PIO-cum-EE(PWD), Boleng Division, Siang District and the Appellant Shri Shoney Pertin appear in the hearing through online video conferencing. The PIO informed that all the information have been furnished to the Appellant. The Appellant also informed that he has received all the information from the PIO and is satisfied with the information furnished to him by the PIO.

Therefore, the case is hereby disposed of.


