ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Raj Pao, Chairman APYGSC, Edu Society, Abotani Colony, Itanagar, PO:PS: Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information, by Shri Otem Tayeng, PIO-cum-JDEE, ESS - Sector, Itanagar, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 05/02/2020.

Whereas, the 1st hearing was held through online Video / Audio conferencing on 4th August' 2020. Shri Otem Tayeng, PIO-cum-Jt. Director (Elementary Education), Itanagar was not accessible in his Mobile No. 9366759112 / 9436258043. However, vide letter No. DEE/PA-04/2028-19 Dated Itanagar, the 4th Aug'2020, Shri Tapi Gao, Director of Elementary Education, Govt. of Arunachal Pradesh, Itanagar informed that Shri Otem Tayeng, PIO-cum-Jt. Director (Elementary Education), is unable to attend the hearing scheduled on 4th August'2020 as he is in containment Zone at East Siang District. The Appellant Shri Raj Pao appeared in the hearing through online video conference. The Appellant informed the Commission that the PIO has not furnished information as sought by him in the Form-A. Since, the PIO was absent argument could not be heard from the PIO.

Therefore, to hear from the PIO, the Commission has decided to fix another date of hearing.

Whereas, the 2nd hearing was held through online Video / Audio conferencing on 15th September' 2020. Shri Otem Tayeng, PIO-cum-Jt. Director (Elementary Education), Itanagar and the Appellant Shri Raj Pao attended the hearing. The PIO informed the Commission that the Appellant was informed to collect information on 20th March'2020 and information sought by the Appellant was sent through the post. The Appellant informed that he has got the informations and he is satisfied with the information furnished for Sl.no. 1 & 2, and he will not insist for Sl.no. 3 of the Form-A. But, the PIO has furnished incomplete information for the Sl.no. 4. The Appellant said that he sought for the complete list of APTET qualified candidates from 2015-19 along with duly attested copies of their BA/Bcom/Bsc, BED, DELED, DIET certificates.
