ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Shoney Pertin, District President NPP, Pasighat, East Siang District, Arunachal Pradesh, for non-furnishing of information, by Shri Jongge Yirang, PIO-cum-DDSE, East Siang District, Pasighat, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 23/01/2020.

Whereas, the 1st hearing was held through online Video / Audio conferencing on 4th August' 2020. Shri Jongge Yirang, PIO-cum-DDSE, Pasighat, East Siang District and the Appellant, Shri Shoney Pertin attended the hearing through online video/audio conference. The Appellant informed the Commission that he has not received the information as sought by him. The PIO vide letter No. ESD/EDN/RTI/2018-19/904 Dated Pasighat the 24th January'2020 forwarded the RTI Application of the Appellant, Shri Shoney Pertin to the Principal, Govt. Hr. Sec. School Mebo as, the information sought by the Appellant falls within the jurisdiction of the Principal. Principal, Govt. Hr. Sec. School Mebo, vide his letter NO. MHSS/RTI/2019-2020/601-02 Dated Mebo the 18th Feb.2020 informed that the information sought is not available in the record. However, the Principal asked the information seeker to have physical verification of the particular person.

Whereas, the Commission viewed that the Principal, Govt. Hr. Sec.School Mebo is PIO himself and the information sought by the Appellant is under the custody of the Principal. The DDSE, Pasighat, East Siang District has acted U/s 6(3) of the RTI Act 2005 and forwarded the Application to the Principal. The Commission asked the Appellant to approach the Principal, Govt. Hr.Sec, Mebo for verification. The Commission also directed the DDSE Pasighat to furnish a copy of the letter written by the Principal to the Appellant. The Commission has also directed to summon the Principal, Govt. Hr. Sec. School, Mebo in the next date of hearing.

Whereas, the 2nd hearing was held through online Video / Audio conferencing on 15th September' 2020. Shri Jongge Yirang, PIO-cum-DDSE, Pasighat, East Siang District Shri Kaling Ratan, Principal, Govt. Hr. Sec. School Mebo, East Siang District, Arunachal Pradesh and the Appellant, Shri Shoney Pertin attended the hearing through online audio conference. Shri Kaling Ratan, Principal, Govt. Hr. Sec. School Mebo, East Siang District, Arunachal Pradesh vide letter no. MHSS/RTI/2019-2020/601-02 Dated Mebo the 18th Feb'2020 informed that the information sought by the Appellant is not available in the record. The Appellant informed the Commission that though information sought by him has not been furnished but the Principal has given in written that the information sought by him is not available in the record, he is satisfied with the reply.

Therefore, the case is hereby disposed of.
