**JUDGMENT/ORDER**

This is a second appeal registered in the APIC, being APIC-No. 13/2020. Brief fact of the case is that one Shri Mamu Sono on 01.11.2019 filed an RTI application under, Form-A of RTI Act, before the PIO-cum-Deputy Director, Horticulture Department, Govt. of Arunachal Pradesh, Itanagar, District Papumpare, Arunachal Pradesh, whereby seeking various information against the ***Staffs position/Staffs strength under the Horticulture Department since its inceptions to till today.***

This appeal came up for hearing before the Commission on 19.02.2020. The appellant Mamu Sono is present. PIO-cum-Joint Director, M. Tani is, though not present, represented by his Branch Officer Mr. G. Angu, Department of Horticulture, Govt. of Arunachal Pradesh.

Meanwhile a written application has been received from the appellant seeking to allow him for withdrawal of the appeal on the ground, among others,

that the department of Horticulture against which he had sought the information has been bifurcated from Agricultural Department in 1987. Heard both parties. After hearing both parties and also after having considered the withdrawal application filed by the appellant I find this appeal fit to be closed on the such request of the appellant.

In view of above facts and circumstances I find this appeal fit to be closed on such request of the appellant. And, accordingly, this appeal stands disposed off and closed for once for all.


