JUDGEMENT ORDER

The appeal under section 19(3) of RTI Act, 2005 has been received from the appellant Shri Doge Riba, D.D Studio Building, Vivek Vihar, College Road, Itanagar, Papumpare Arunachal Pradesh for non-furnishing of information, by the PIO Er. Karom Perme, S.E.(Coord), DHPD,O/o the Superintending Engineer (Coord)Department of Hydro Power Development,Vidyut Bhawan, Itanagar, Papumpare Distt. A.P. as sought, by the appellant under section 6(1) of RTI Act, 2005 on 01.11.2019.

Whereas, the 1st hearing was held on 17th February 2020, The appellant Shri Doge Riba, D.D Studio Building, Vivek Vihar, College Road, Itanagar, Papumpare Arunachal Pradesh was present and while one Shri Hibu Laling APIO on behalf of PIO, Er. Karom Perme, S.E.(Coord), DHPD,O/o the Superintending Engineer (Coord)Department of Hydro Power Development,Vidyut Bhawan, Itanagar, Papumpare Distt. A.P was also present during the hearing.

The appellant informed that the PIO did not furnish the information as per his RTI application Form-A and the PIO admitted that the information could not be furnished as per the application file by appellant.

However, the representative of PIO who was present in the court proceeding and given his assurance to furnish information within one week i.e. by next Friday 21.02.2020.

The appellant has been directed to inform the hon'ble Commission after received of information from PIO and say whether his is satisfied or not satisfy with the information so furnish by PIO. The appellant should immediately inform this commission on received of all information from PIO, so that the instant case can be disposed off thereafter.
