In terms of Section 16 (2) of the said Act, as amended by the RTI (Amendment) Act, 2019 read with Rule 12 of the Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019, the Governor of Arunachal Pradesh is further pleased to order that the Chief Information Commissioner shall hold office for 3 (three) years from the date of his entering upon the office or till he attains the age of 65 (sixty five) years whichever is earlier.

The Governor of Arunachal Pradesh is further pleased to order that salaries, allowances and other terms of service of the State Chief Information Commissioner shall be regulated under rules 14 to 20 of the said Rules.
