**ORDER**

This is with reference to your joint application vide dtd. 03/03/2022. The APIC Court of Shri Gumjum Haider, Hon'ble SIC had communicated to Superintendent of Police SIC (Vig), AP Civil Secretariat, Itanagar vide letter no. APIC No.68/2021/713 dtd 30/09/2021 to provide the information pertaining to the work "Construction and Improvement of Seppa-Chayangtajo Road under NEC" as sought by the appellant. But, the SP, SIC, (Vigilance) had intimated vide their letter No.SIC/VIG/RTI/50/2021/1229-30 dtd 20<sup>th</sup> October, 2021 that the information / documents pertaining to said work, which have duly been seized in connection with the Case may hamper/impede the due process of investigation as the case is of a very sensitive nature. The same has been intimated to you already.

Therefore, under Sub-Section '1' of Clause 'h' of Section '8' of RTI Act, 2005 the information cannot be furnished at present. The appellant may seek for the information afresh from the PIO-cum-EE (PWD) Chayangtajo, Division on completion of the investigation process of the case by SIC (Vigilance) with an intimation to this Commission.
