SHOW CAUSE NOTICE

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

To,

PIO-Cum-EE, PHE & WS Yingkiong
Division, Upper Siang Distt., A.P.

WHEREAS, Shri Tana Roma Tara filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 20.07.2022 U/S 19 (3) of RTI Act, 2005 vide **Appeal No. APIC-483/2022**, wherein, alleging against you that you have failed to furnish information sought by the Appellant under Form-A of his application dated 04.05.2022 relating the matter as quoted in Form-A application.

WHEREAS, you, being PIO-Cum-EE, PHE & WS Yingkiong Division, Upper Siang District, Arunachal Pradesh have refused to furnish the information sought under **RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.**

WHEREAS, date of hearing of the Appeals was intimated to you in advance but you were found absent consecutively dated on **12.09.2022, 17.10.2022, 07.11.2022 & 16.01.2023** without giving reason of his absence to the Commission. Therefore, the Commission viewed seriously as found the PIO repeated absence during the hearing So, it is liable to impose reasonable penalty of your negligence in furnishing of the informations as sought by the Appellant.

NOW THEREFORE, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing on **6th February, 2023 at 1030 hrs** and to furnish the reply of the Show-Cause Notice issued against you on or before **6th February, 2023 at 1030 hrs** as to why you should not be imposed a reasonable penalty as per the Section 20 (1) of the RTI Act for violation of Sub Section (1) of the Section 7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.
