**SHOW CAUSE NOTICE**

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

**WHEREAS,** Shri Yorri Pale filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 11.10.2022 U/S 19 (3) of RTI Act, 2005 vide Appeal **No. APIC-729/2022**, wherein, alleging against you that you failed to furnish information sought by the Appellant under Form-A of his application dated 07.07.2022 relating to the matter as quoted in Form-A application.

**WHEREAS,** you, being PIO-Cum-SE, Coordination, PWD, Nirman Bhawan Building, 3<sup>rd</sup> Floor, Ziro Point, Itanagar Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under the sub section (1) of section-20 of the Act.

**WHEREAS,** date of hearing of the Appeals was intimated to you well in advance but you found absent on **23/01/23** during the hearings without giving reason of your absence to the Commission. The Commission seriously viewed the repeated absence of the PIO and found liable for imposing reasonable penalty of your negligence in furnishing of the informations as sought by the Appellant.

**NOW THEREFORE,** you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the replies to Show-Cause Notice against you on or before **3<sup>rd</sup> Feb, 2023 at 1030 hrs in the Chamber of undersigned** as to why you should not be imposed a reasonable penalty as provided in Section 20 (1) of the RTI Act for violation of Sub Section (1) of the Section 7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.
